**ORDER:**

In Government letter 14<sup>th</sup> read above, Government have addressed the District Collector, Coimbatore District to send a panel of Advocates to Government along with their Application containing Bio-data, with due verification for appointment of Law Officers on tenure basis for subordinate courts in the District, as per the provisions contained in Section 18 of BNSS, 2023 and Government Standing Order issued in Government order 1<sup>st</sup> read above.

2. In Government order 16<sup>th</sup> read above, in view of the exigency caused by resignation, termination, completion of tenure of Law Officers appointed to the courts subordinate to the High Court of Madras and creation of new courts in the Districts, and the need for filling of those posts on emergency basis to avoid those posts remaining vacant and to ensure that the cases pending before them do not go unrepresented from the Government side, the Government have issued orders for appointing Law Officers temporarily for a period of six months or till the Law Officers are appointed to the courts on tenure basis whichever is earlier.

3. The District Collector, Coimbatore in his letter 17<sup>th</sup> read above, has sent a proposal containing the list of Advocates who have eligibility for appointment as Law Officers on temporary basis in various Subordinate Courts in Coimbatore District for a period of six months or until Law Officers are appointed on tenure basis whichever is earlier based on the orders issued in the Government order 16<sup>th</sup> read above. He has stated that such temporary appointment would ensure uninterrupted representations of the Government before the courts and avoid any administrative inconvenience during the intervening period.

4. The Government after careful examination of the above proposal of the District Collector, Coimbatore, hereby appoint the following Advocates as Law Officers in the posts mentioned against their names to the various Courts Subordinate to High Court of Madras in Coimbatore District on temporary basis for the period of six months or till Law Officers appointed to the respective courts on tenure basis whichever is earlier, as per the Orders issued in the Government order 16<sup>th</sup> read above:-

5. The Government further order that, the appointment of the Law Officers mentioned in paragraph 4 above is purely on temporary basis for the period of six months only or till the tenure appointment are made by the Government by following the due procedure.

6. The Government also order that their services are liable to be terminated at any time without prior notice and they are eligible to claim fees as per orders issued in Government order 8<sup>th</sup> read above.

7. The District Collector, Coimbatore is requested to serve this order to all concerned and send a report regarding taking over of the charge immediately.
